

## Contest Rules and Regulations

### The Family Fave Recipe Contest (a.k.a. Gateway Create Contest)

#### 1. CONTEST PERIOD

The **Family Fave Recipe Contest** (the "Contest") is run by Canada Beef (the "Administrator") as the sole operator and provider of the Contest. The Contest will take place in all Canadian provinces excluding Québec – English language only. Contest entries will be accepted from Aug 29 2023 (10:00 am ET) to Sept 30 2023 (Midnight ET), (the "Contest Period").

#### 2. CONTEST GROUP

For the purposes of the Contest, the "Contest Group" is composed of the Administrators, together with advertising and promotion agencies, suppliers of material and services related to the Contest, and any other corporation, partnership, sole proprietorship or other legal entity to the benefit of which this Contest is held, as well as their respective officers, directors, employees, agents, and other representatives.

#### 3. ELIGIBILITY

The Contest is open to all individuals who:

- (a) reside in Canada, excluding Quebec; and
- (b) have reached the age of majority in their province of residence; and

Employees, agents and other representatives of the Contest Group, as well as any person with whom they reside, are not eligible to enter the Contest.

#### 4. METHODS OF ENTRY

##### 4.1.

No purchase necessary. To enter the Contest, you will need to complete the Entry Form, answering all mandatory questions and fields provided, plus complete the Recipe Template with the Ingredients and Method portions filled in and click Submit. At the end of the Contest period, all Potential Winners selected must correctly answer a mathematical skill-testing question to be deemed a Winner. There is a limit of one (1) submission per individual email address during the Contest Period.

For Mail-in Entry, print off the Entry Form and fill in the mandatory fields. Fill in the on-line Recipe Template Form and print off your completed recipe. Mail-in the completed Entry Form plus Completed Recipe Template Form with a post-marked date no later than Sept 30 12:00 pm ET to:

4.2.

Although online access is required in order to participate, no purchase is required in order to participate in the Contest.

4.3.

If you opt to enter this Contest via your wireless mobile device (which may only be available via participating wireless carriers), standard text messaging and/or data rates may apply according to the terms and conditions of your services agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Wireless carriers' rate plans may vary, and you should contact your wireless carrier for more information on messaging rate plans and charges relating to your participation in this Contest. Participation in this Contest by mobile device means that you understand that you may receive additional messages by mobile device relating to the Contest, including notifying you if you are the potential Prize-winning qualifier (if applicable), which may be subject to charges pursuant to your carrier's rate plan. Mobile device service may not be available in all areas. Check your phone's capabilities for specific instructions before completing the Entry via your wireless mobile device.

## **5. PRIZES**

1. One (1) Grand Prize eligible to win by an entrant. Potential winner to be selected by random draw from all Qualified Contest Entrants. The Grand Prize includes: 1x [Big Green Egg MiniMax](#) barbecue/smoker + 1 x [Canada Beef Steak Your Claim prize pack](#). Approximate value in total is \$1245.00

2. PLUS 5 Recipe Winners. Each Recipe Winner will receive prize of \$1000.00 cash (in the form of a Visa Gift Card) plus a Canada Beef [Look What's Cooking prize pack](#). Approximate value in total is \$1120.00. Winning recipes will be professionally edited and posted on the [Canadian Beef Information Gateway](#) as part of a Winners Circle collection of recipes, with imagery and video that Canada Beef creates to represent the recipe.

## **6. TWO WAYS TO WIN:**

**NOTE – TO BE A QUALIFIED ENTRANT, ALL MANDATORY FIELDS OF THE ENTRY FORM MUST BE COMPLETED**

### **1. RANDOM DRAW**

Once the Contest Period closes, one (1) entry will be randomly drawn from all Qualified Contest Entries received during the contest period (on-line + mail-in entries). A representative of the Administrator acting reasonably, will attempt to contact the potential Prize Winner selected from the Draw within two (2) business days after the draw to notify potential winner. Three (3) attempts to contact each winner will be made (within and outside of business hours ET).

In the event that the potential Prize Winner cannot be contacted within two (2) business days after the draw, he or she will be disqualified and an alternate winner will be drawn at the Administrator's sole discretion. Proof of identification must be provided upon request. A

mathematical skill-testing question needs to be answered correctly in order to be declared the Winner.

**ODDS OF WINNING:** The odds of winning will depend on the total number of entries received during the Contest Period.

## **2. SELECTION OF 5 RECIPE WINNERS**

Once the Contest Period closes, the recipe submissions will be sorted and evaluated by a recipe development professional for evaluation and judgement as a winning recipe. The quality of the recipe story submitted along with the recipe will add to the value of the recipe submission. A representative of the Administrator acting reasonably, will attempt to contact the Prize winners within two (2) business days after the winning recipe selection to notify a potential winner – 3 attempts will be made to contact each winner (within and outside of business hours ET).

In the event that the potential Prize winner cannot be contacted within two (2) business days after the winning recipe selection, he or she will be disqualified and an alternate winner will be selected at the Administrators sole discretion. Proof of identification must be provided upon request.

## **ODDS OF WINNING**

The odds of winning will depend on the total number of entries received during the Contest Period per recipe category, the quality of the recipe and accompanying recipe story.

## **8. AWARDING OF PRIZES**

### **8.1.**

To be declared a winner, a selected entrant must, in addition to meeting the Contest eligibility criteria and otherwise complying with the Contest Rules, first: be reached by email by the Administrator or its representatives within two (2) days immediately following the selection of the Entry; have correctly answered a mathematical skill-testing question; sign and have witnessed the declaration and release documentation and return it to the address indicated in the documentation for it to be received within seven (7) days following its delivery by the Administrator or its representatives. **The declaration form can be photographed or scanned and returned to [info@canadabeef.ca](mailto:info@canadabeef.ca).**

### **8.2.**

Disqualification: If any one of the conditions mentioned in the Rules is not met, the selected entrant will be disqualified and shall not be entitled to receive any prize, and the Administrators reserve the right, in their sole and absolute discretion, to select at random another eligible entrant as a potential prize winner or to cancel the prize.

### **8.3.**

Delivery of Prize: Following receipt of the selected entrant's correctly answered a mathematical skill-testing question, signed declaration and release documentation, the Administrators will send the prize to the winner. Please allow four (4) to six (6) weeks for delivery. Shipped prize shall not be insured and the Administrators shall not assume any liability for a lost, damaged or misdirected prize.

## **9. GENERAL TERMS AND CONDITIONS**

### 9.1.

Verification of Entries: The validity of any Entry is subject to verification by the Administrators. Any entries that are illegible, incomplete, fraudulent or otherwise non-compliant with the Rules, will be disqualified. Any entrant or other individual who enters or attempts to enter the Contest in a manner that is contrary to these Contest Rules or that is otherwise disruptive to the proper operation of the Contest or by its nature is unjust to other entrants or potential entrants will be disqualified. All decisions made by the Administrators or its representatives, including without limitation those concerning the eligibility or disqualification of entrants, are final and binding without right of appeal. All entries become the property of the Administrators and none will be returned.

### 9.2.

Acceptance of Prize: Prize must be accepted as described in these Contest Rules and cannot be returned, transferred to another individual, substituted for another prize or exchanged in whole or in part for money, except as set out in Rule 9.3.

### 9.3.

Substitution of Prize: The Administrators reserve the right, in its sole and absolute discretion, and for any reason whatsoever, to substitute for any prize, or part thereof, another prize of equivalent or greater value, including, without limitation, a cash award.

### 9.4.

Number of Prizes/Winners: By entering the Contest, each entrant acknowledges that the Administrators shall not be required under any circumstances to award more prizes than the number of available prizes, as set out in these Contest Rules. In the event that, for any reason whatsoever (including, without limitation, as a result of an error, malfunction or defect in the design, advertising, management, implementation or administration of the Contest, whether mechanical, electronic, human or otherwise) the number of declared winners or the number of prizes claimed by entrants is greater than the number of prizes available, the Administrators reserve the right, in its sole and absolute discretion, to end the Contest in whole or in part, without notice.

### 9.5.

Other Changes to Contest Rules: Without limiting the provisions of Rule 9.4 above, the Administrators reserve the right, in its sole and absolute discretion, to modify, cancel, terminate or suspend the Contest, in whole or in part, in the event of any cause or circumstance, including, without limitation, any virus, computer bug or unauthorized human intervention or any other cause that is beyond the control of the Administrators, that could corrupt or affect the administration, security, impartiality or normal course of the Contest.

9.6.

Release and Exclusion of Liability:

By the Entrants: By entering or attempting to enter the Contest, each entrant and/or purported entrant agrees: (i) to release, discharge, and forever hold harmless the Contest Group and their shareholders from any and all claims, actions, damages, demands, manner of actions, causes of action, suits, debts, duties, accounts, bonds, covenants, warranties, indemnities, claims over, contracts and liabilities of whatever nature or kind arising out of, or in connection with the entrant's participation or attempted participation in the Contest, compliance or non-compliance with these Contest Rules and acceptance and use of the prize. Any entrant selected for a prize acknowledges that upon awarding of the prize, the obligations typically borne by the provider of services or goods become that provider's responsibility; and (ii) if selected as a potential winner, to sign the declaration and release documentation (see Rule 8.1) in this regard before receiving his/her prize. The Contest Group and their shareholders will not be responsible for lost, incomplete, late or misdirected entries or for any failure of the Contest website, if applicable, during the Contest Period, or for any technical malfunction or other problems with, any telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software or for any technical problems or traffic congestion on the Internet or at any website, or any combination of the foregoing, and will not be liable for any resulting death, injury or damage to any person or property arising from, or relating to, that person's or any other person's participation or attempted participation in the Contest. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and, should such an attempt be made, the Administrators reserve the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution

9.7.

Personal Information: Unless the entrant has otherwise authorized the Administrators or another entity related to the Contest to contact him or her, the personal information gathered about entrants in connection with this Contest will be used solely for the administration of the Contest and is subject to Canada Beef's privacy policies (available at <https://canadabeef.ca/privacy-policy/>) and no communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant by the Administrators. Posting of the Winners' names and city location will be posted by Canada Beef on Canada Beef digital and social media platforms to confirm legitimacy of the contest with the public. Identity of the Entrant: For the purposes of these Contest Rules, the entrant is the person who is the holder of the email account used to enter the Contest. It is to this individual that the Prize will be awarded if selected and declared as the winner.
